### **PUBLIC COMMENT**

### **JAIL SENIOR STAFF REPORTS**

Warden Quigley announced Deputy Warden Stephanie Smith was the recipient of the Francis "Fran" Drexler Public Safety Award presented by the Council on Chemical Abuse.

Warden Quigley stated the inmate population was 1,037. Of the population reported, 38 inmates were technical parole violators and 97 were residing in the Community Reentry Center.

Chief Deputy Warden Jeffrey Smith reported the staffing update: 2 correctional officer vacancies, 9 cadets started the academy October 19, 6 cadets pending medical screens were scheduled to start November 30. A discussion took place regarding staffing and training.

Deputy Warden Kyle Russell updated the Board on the Professional Visitor Interview Rooms renovation project, stating the project was three quarters complete. Deputy Russell mentioned the back end of the jail had been cleaned out thanks to the metal recycling contract.

CDI Kimball was working on an analysis of the renovations or new construction of the 1933 and 1993 portions of the jail. Deputy Russell received a draft of the agreement for the purchasing team to review before execution. A discussion took place about project management.

Deputy Warden Smith updated the Board on programs: Mental Health First Aid training was provided to all supervisors as well as the SOG team. The medication assistant treatment program which started last month had successfully inducted two inmates into the program.
