Presentation:

Mr. Gerlach reviewed the capital market for the Board. He said economic growth continued in the fourth quarter of 2009 and is expected to continue. Emerging markets equity was up 80% high yield was up 58%.

Mr. Gerlach said there was value in staying invested and resulted in the extraordinary returns on the rebound.

Mr. Haverly said the portfolio allocations of 43.4% Fixed Income, 43.3% U.S. Equity, 13.1% International Equity and 2% cash and equivalents were in line with the reallocation as of November 2009.

Mr. Haverly said the total portfolio returns for the fourth quarter were 4.2% with the index benchmark at 2.9%. For 2009, the total portfolio was up 27.5% with the benchmark at 21.0% adding 6.5% over the benchmark.

To date through January 19, the Fund is up to \$228.6 million, up 5.8% since inception September 30, 2008.

Mr. Haverly said SEI will continue monitor asset allocations and continue to look for new opportunities.

Mr. Haverly provided members of the Board with the new investment policy, as previously approved, for their signatures.
