Berks County Salary Board Thursday, May 2, 2024

The Berks County Salary Board members met on Thursday, May 2, 2024, at 8:30 am in the Commissioners' Board Room on the 13th floor of the Berks County Services Center and through a Microsoft Teams Live Event virtual meeting, pursuant to due notice to the Board members and the public. Controller Joseph E. Rudderow called the meeting to order with Commissioner Christian Y. Leinbach, Commissioner Michael S. Rivera, Commissioner Dante Santoni, and County Solicitor Christine M. Sadler in attendance.

Controller Rudderow questioned why his request for an additional Account Clerk II position is not on the May's Salary Board Agenda. The burden to process Accounts Payable is falling on one person. Controller Rudderow has concerns and disappointments if his request is not listed for next Salary Board meeting. He would like to be more involved in the process and stressed better communication from Vacancy Review about the status of the request.
