Commissioners' Board Meeting May 5, 2011

The Berks County Board of Commissioners met in regular session on Thursday, May 5, 2011, at 10:30 A.M. in the Board meeting room on the thirteenth floor of the Berks County Services Center, pursuant to due notice to Board members and the public.

Commissioner Chair Mark C. Scott, Esq. called the meeting to order with Commissioner Christian Leinbach and Commissioner Kevin Barnhardt in attendance. Also present were Solicitor Alan Miller Esq., Interim Chief Operations Officer Kenneth C. Borkey, Jr. and Chief Clerk Maryjo Gibson.

Commissioner Scott opened the meeting with a moment of silence and Pledge of Allegiance to the Flag, and announced that the Board met in Executive Session Tuesday, May 3, 2011 to discuss personnel matters.

Approval of Minutes

The minutes of April 26, 2011 Commissioners' Workshop and April 28, 2011 Commissioners' meetings were approved as presented.

<u>Reports</u>

- County Treasurer Nelson Long, CPA submitted a prepared weekly Treasurer's report. Mr. Long commented that tax receipts so far this year are 10.9 million compared to 6.7 million this time last year. Commissioner Leinbach questioned whether the special Tax Claim program had any affect on this amount. Mr. Long replied yes. Thousands participated. Commissioner Scott put Treasurer Long on notice that Exeter Township will be contacting him to request that when Tax Claim Bureau collects back taxes, they would like them distributed by millage, i.e. hydrant, fire and trash.
- 2. The Controller's weekly report was presented by Deputy County Controller Mark Hanson.
