#### Old Business:

Mr. Miller said he received a list from Human Resources of the part time employees participating in the Pension plan. Some employees on the list had previously been employed full time. Mr. Miller said he would draft a policy regarding part time participation in the County's Pension Plan for Board's review by the next meeting.

Mr. Miller said he reviewed the proposed contract with Peirce Park Group (PPG) and recommended the Board use a three-year term with a thirty day termination clause. The Board agreed and asked Mr. Miller to contact PPG regarding the language changes to the contract.

Ms. Baer said she had been using the Pension Estimator since fall of last year to prepare preliminary pension estimates for employees. The estimator provides accurate information in seconds without going through the accountant or actuary, and added that she also uses the estimator to show terminating employees the pension benefit they would forfeit if they choose not to vest. Ms. Baer offered to demonstrate the pension estimator in her office for the Board members

The Board authorized the disbursements on motion by Mr. Long and second by Ms. Graffius pending review by Judi Lumis. Motion carried with a no vote from Mr. Long.
