APPROVAL OF MINUTES

CORRESPONDENCE

Correspondence was reviewed.

OLD BUSINESS

Jessica Weaknecht and Ron Seaman meet with Kelly Laubach on the potential of moving to an RFP for the Pension Actuary search. Jessica felt this would be more beneficial and best course of action. Ms. Weaknecht asked if the Board had any concerns with going this route. A motion was made by Commissioner Barnhardt to go through the process. Commissioner Chair Leinbach reported the Berks County Employees' Retirement Fund balance as of March 20, 2019 is \$460,468,222.15.

Solicitor Christine Sadler suggested doing a contract extension for the Korn Ferry contract while we await the results of the RFP. A motion to extend the Korn Ferry contract for an additional 6 months was made by Commissioner Barnhardt and seconded by Commissioner Scott. Motion carried.
