The Berks County Board of Commissioners met in regular session on Thursday, June 23, 2011, at 10:30 A.M. in the Board meeting room on the thirteenth floor of the Berks County Services Center, pursuant to due notice to Board members and the public.

Vice Chair Commissioner Kevin Barnhardt called the meeting to order with Commissioner Christian Leinbach and Commissioner Chair Mark C. Scott in attendance. Also present were Solicitor Alan Miller and Chief Clerk Maryjo Gibson.
