NEW BUSINESS

- 1. Commissioner Barnhardt questioned if the buyback amount for Claribel Morales was correct; it seemed a small amount for 12 years of service. Commissioner Leinbach asked to have that amount verified with Suzanne Baer.
 - While the Board waited for a response, a motion was made by Commissioner Barnhardt to approve items a. and c. Said motion was seconded by Ronald Rutkowski, and all voted unanimously to authorize buybacks for James Gresh and Donna Sylvester.
 - Christie Bennett-Zellers reported the \$27,579.06 is correct; Ms. Morales was hired in 2005 on a part time basis, and transferred to full time in 2013.
 - A motion was then made by Commissioner Barnhardt to approve item b., said motion was seconded by Dennis Adams, and all voted unanimously to authorize buyback for Claribel Morales.
 - 11R.2018 Adopt a resolution authorizing employee buyback requests as follows:
 - a. James D. Gresh purchasing 323 days of Military Service in the amount of \$5,076.24.

- b. Claribel Morales buying back previous service time of 12 years, 9 months and 2 days from November 28, 1990 to August 29, 2003 in the amount of \$27,579.06.
- c. Donna M. Sylvester buying back Leave of Absence time 2 months, 22 days from September 30, 2010 to December 3, 2010; November 9, 2015 to November 29, 2015 and April 29, 2016 to May 13, 2016 in the amount of \$1,275.96.
