# **AGENDA ITEMS**

# 1. <u>Discussion and Approval of Election Day Compensation for Day Shift,</u> Overnight Workers, and Call Center Staff

Anne Norton led a discussion about compensation for County employees who help with Election Day duties, including the opening of mail-in ballots throughout the day and overnight and manning a call center to answer inquiries from voters. The Primary Election is a regular workday for County employees, so employees assisting with election-related tasks would receive their usual compensation, plus \$200, which is equivalent to what poll workers are paid. Employees working the overnight shift would receive their regular pay for Election Day and the following day, with supervisor approval, but would not report to work during their regular shifts since they are working through the night.

On the motion of Judge Gavin, seconded by Judge Koestel, the board approved the Election Day compensation for day shift, overnight workers and call center staff.

# 2. Permanent Polling Place Change for Maidencreek 3

Anne Norton explained to the Board that the polling place would be moving back to its permanent location after being temporarily relocated due to COVID-19 concerns. A notice of the change would be mailed to the affected voters.

On the motion of Judge Gavin, seconded by Judge Koestel, the board approved changing the polling place for Maidencreek, Precinct 3, for the upcoming May 16, 2023 Municipal Primary as follows:
