Berks County Salary Board Thursday, September 5, 2024

The Berks County Salary Board members met on Thursday, September 5, 2024, at 8:37 am in the Commissioners' Board Room on the 13th floor of the Berks County Services Center and through a Microsoft Teams Live Event virtual meeting, pursuant to due notice to the Board members and the public.
