Please consult your local Building Code Official for the code(s) and version(s) that are applicable to appeal.

Complete the attached forms as follows:

1. Complete the Applicant/Agent Property Owner and Property Location information.
2. Note: The hearing format provides for testimony from witnesses and/or counsel as deemed required by the applicant. All people whom present information will be testifying under oath during the proceedings. The Appeals Board may have legal counsel present and a stenographer at the hearing.
Fee: (A) \$2,500.00 for a Residential Appeal under the International Residential Code (one and two family dwellings.)
(B) \$5,000.00 for a Non-residential Appeal
3. Select the appropriate ICC Code for which the appeal is requested. Attach a copy of the municipality's written denial and a copy of the code section for which relief is being requested. Check the appropriate ICC Code and provide the code section number on the space provided.
4. Select the reason for the appeal.
5. Provide supporting documentation and/or the relief requested from the Pennsylvania Uniform Construction Code. Use separate sheet if necessary.
6. Complete Certification Page with Notary signature and seal.
7. Provide eight (8) **additional** copies of all documentation provided which is larger than 8-1/2" X 11".

Payment of Hearing fee is due at time of filing of application. Checks shall be made payable to Berks County Treasurer.
