BERKS COUNTY PRISON BOARD MINUTES MARCH 31, 2021

APPROVAL OF MINUTES

A motion was made by Kevin Barnhardt to approve the February 24, 2021 meeting minutes as presented. Motion carried.

PUBLIC COMMENT

None.

JAIL SENIOR STAFF REPORTS

INMATE POPULATION: Acting Warden Jeffrey Smith stated the inmate population was 727. Of the population reported, 659 were male and 68 were female. Five juveniles 2 at Chester County 3 at Lehigh County. There are Seven Veterans. Forty-four inmates sentenced and within the next 4 weeks 24 of those inmates are scheduled to leave. As of February 26th, the intermittent sentences have resumed. The mental health roster will include 70 D roster, 366 Z roster.

STAFFING: Acting Warden Jeffrey Smith updated the Board on the status of staffing: there were 20 correctional officer vacancies; 19 custodial and 1 maintenance. There were 6 cadets in the academy which will be graduating in May. The next CO testing is scheduled for April 7th. Jeff explained the vacancies are caused by employees retiring or moving on or change of career choices. Covid was stalling the hiring process.

COVID UPDATES: Acting Warden Jeffrey Smith updated the Board on the status of staffing: there are 3 staff that are positive and 7 inmates that are positive.

FACILITIES & MAINTENANCE PROJECTS: Acting Warden Jeffrey Smith updated the Board on the status of projects: Multi-purpose room, offices and video conference rooms are still in process. The projected move in date is April 30th.

Delta room painting project pending the complication with completion date set at April 30th.

The trailers will be delivered the week of April 7th with a target move in date of early to mid-May.

AB Visitation had a few manufacturing delays with the vendor Uhrig. There is not a set target date on this project.

Switch Gear project is awaiting on vendor designing the gear. Generator transfer switch should be scheduled for April 13th this would depend on the gear being shipped which may take several weeks.

End cell heating coils is having difficulty communicating with all the heating units. The vendor has requested a change order. There is no target date currently.

Internal fencing project will be proceeding with this project.

EVENTS, PROGRAM & TRAINING: Deputy Warden Stephanie Smith updated the Board on the Vivitrol Program. She reminded the Board this was a 2-year grant which is approaching the grant will end in June. Stephanie reached out to PPCD and DOC who provides these funds. They will be reaching out to the grantees in April and offering a one year no cost addition to the grant. This would extend this grant into 2022. There is a lot of funds remaining in the current grant. If there is an am extension the board would be updated when there is a plan or a proposal. The number of people that were helped by Vivitrol is reported to PPCD. Those inmates are tracked a year after release. The grant funds are billed down as it is used.

SOLICITOR'S REPORT

Solicitor Sadler required an Executive Session which did not require action from the Board.

Acting Warden Jeffrey R. Smith thanked the members of the Prison Board for having the confidence in him. He is looking forward to and excited for his new role as Warden. Mr. Smith wanted to take the time to thank every employee that works inside the jail. He would not be able to do this without them.
