# BERKS COUNTY EMPLOYEES' RETIREMENT FUND BOARD MINUTES February 21, 2019

A motion was made by Commissioner Barnhardt, seconded by Controller Graffius to do an RFI for both Korn Ferry, our actuary and a Pension Advisor. Christian Leinbach assigned Jessica Weaknecht to work with Purchasing to see what other actuaries are in the field. The RFI for the actuary is due for the next meeting in March and the RFI for the Pension Advisor is due for the April meeting. Commissioner Scott suggested using the SEI model as the preferable type of advisor we are looking for, and to include a layer of compensation and fees; something we are not seeing with SEI. The Board as a whole seems to want a better understanding of what fees we are currently paying with SEI. Motion carried.

#### **AUTHORIZE DISBURSEMENTS**

A motion was made by Dennis Adams, second by Sandra Graffius to authorize the disbursements of annuities and refunds for January 2019. Motion carried.
