Old Business:

The Board discussed the employee buy-back policy. Ms. Baer provided examples on how buy-backs effected an employee's service time and benefit amount. The Board directed Ms. Baer to contact Hay Group to see if employee buybacks were included in their calculations and if there were other options that could be offered to employees.

New Business:

Ms. Lumis said that Grant & Eisenhofer was not aware SEI had taken over ownership of the Pension's Funds assets. Ms. Baer spoke with Chip Greenberg who said from the date they took over the assets, SEI would perform security litigation monitoring and all aspects of the litigation. Mr. Greenberg suggested keeping Grant & Eisenhofer for pre-existing accounts prior to the implementation of SEI. Grant & Eisenhofer does not complete proof of claim forms which previously M&T completed as the Fund's custodian. The Board directed Ms. Baer to contact Grant & Eisenhofer to request that they continue monitoring the pre-existing accounts for the next year and also contact M&T to see what their fee would be to complete the proof of claim forms.

The Board authorized the disbursements on motion by Ms. Graffius and second by Mr. Long pending Ms Lumis' review and approval. Motion carried.
