This policy shall become effective March 1, 2009. Employees in the process of payroll deduction for these types of buy back and/or purchases prior to March 1, 2009 are not subject to this policy for that particular buy back and/or purchase. After discussion, Ms. Baer said she would add a paragraph to the current buy-back form. The paragraph would make it clear to employees that if the employee severs from the county or becomes deceased before the buy-back is paid in full; the employee would not receive service time for the buy-back. seconded by Mr. Barnhardt to add a paragraph to the buy-back form as stated. by Ms. Baer. Motion carried.

Ms. Graffius had made three attempts to contact Controller Jack Mc Millen from Butler County to obtain the status of their attempts to raise the class basis or lowering the benefits for new hires and was unsuccessful. Sue Webber, Erie County Controller, had a meeting with State Senator Jane Earl regarding Act 96 and the determination of cost of living adjustments.

The Board agreed to postpone making a decision on changes to its Asset Allocation and Investment Policy until further information could be obtained from SEI.

New Business:

Mr. Barnhardt moved, seconded by Mr. Long, to approve the employee buy back request as listed. Motion carried.

Carol Casantini, to buy-back 5 years previously refunded at \$11,283.74.

The Board authorized the disbursements on motion by Mr. Long, second by Mr. Barnhardt. Motion carried.
