Commissioners' Board Meeting August 12, 2010

The Berks County Board of Commissioners met in regular session on Thursday, August 12, 2010, at 10:30 A.M. in the Board meeting room on the thirteenth floor of the Berks County Services Center, pursuant to due notice to Board members and the public.

Commissioner Chair Mark C. Scott, Esq. called the meeting to order with Commissioner Christian Leinbach and Commissioner Kevin Barnhardt in attendance. Also present was Chief Clerk Terry Styer. Solicitor Alan Miller Esq., did not attend.

Commissioner Scott opened the meeting with a moment of silence and Pledge of Allegiance to the Flag.

Commissioner Scott presented an amended letter drafted by Gavin Biebuyck of Liberty Environmental Inc. intending to provide comments to the US EPA Region 3 Administrator on the EPA's proposed lead nonattainment designations for Berks County and providing recommendations for revised area boundaries. He explained that the changes were intended to emphasize the "Lyons area" and request that it be designated as non-classifiable instead of lead non-attainment due to East Penn Manufacturing's recent improvements air quality testing results. With this amendment the letter was authorized and signed with a motion made, seconded and approved by the board.
