# Commissioners' Board Meeting May 26, 2011

The Berks County Board of Commissioners met in regular session on Thursday, May 26, 2011, at 10:30 A.M. in the Board meeting room on the thirteenth floor of the Berks County Services Center, pursuant to due notice to Board members and the public.

Commissioner Chair Mark C. Scott, Esq. called the meeting to order with Commissioner Christian Leinbach and Commissioner Kevin Barnhardt in attendance. Also present were Solicitor Alan Miller and Chief Clerk Maryjo Gibson.

Commissioner Scott opened the meeting with a moment of silence and Pledge of Allegiance to the Flag.

#### Approval of Minutes

The minutes of May 17, 2011 Commissioners' Workshop and May 19, 2011 Commissioners' meetings were approved as presented.

## Consent Agenda Items

- 1. A motion was made by Commissioner Barnhardt, seconded by Commissioner Leinbach and all voted unanimously to approve the items listed below:
  - 158.11 A. Adopt a resolution authorizing 2011 Budget Transfers in the amount of \$86,169.00 and 2011 Appropriations in the amount \$250,708.00 per listing dated May 20, 2011.
  - 159.11 B. Adopt a resolution authorizing Human Resource Recommendations per listing dated May 24, 2011.
  - 160.11 C. Adopt a resolution authorizing execution of the Collective Bargaining Agreement between the County of Berks and SEIU Healthcare PA effective January 1, 2011 through December 31, 2015.
