Commissioners' Board Meeting Minutes July 28, 2011

The Berks County Board of Commissioners met in regular session on Thursday, July 28, 2011, at 10:30 A.M. in the Board meeting room on the thirteenth floor of the Berks County Services Center, pursuant to due notice to Board members and the public.

Commissioner Chair Mark C. Scott, Esq. called the meeting to order with Commissioner Christian Leinbach and Commissioner Kevin Barnhardt in attendance. Also present were First Assistant County Solicitor Christine Sadler and Chief Clerk Maryjo Gibson.

Commissioner Scott opened the meeting with a moment of silence and Pledge of Allegiance to the Flag.

Approval of Minutes

The minutes of July 19, 2011 Commissioners' Workshop and July 21, 2011 Commissioners' Meeting were approved as presented.
