## Commissioners' Board Meeting December 4, 2008

The Berks County Board of Commissioners met in regular session on Thursday, December 4, 2008, at 10:30 A.M. in the Board meeting room on the thirteenth floor of the Berks County Services Center, pursuant to due notice to Board members and the public.

December 4, 2008, marks the 86<sup>th</sup> annual observance of Youth Day, a cooperative effort of the Berks County Intermediate Unit, the Greater Reading Chamber of Commerce and Industry, and many businesses and government agencies from across Berks County, for the purpose of providing young people of our community an opportunity to acquaint themselves with their future responsibilities as productive members of a democratic society, while stimulating public interest in the potential of youth.

Commissioner Chair Mark C. Scott called the meeting to order with Commissioner Christian Leinbach and his student counterpart Andrew Green from Exeter High School, as well as Commissioner Kevin Barnhardt and his student counterpart Kate Carpenter from Governor Mifflin High School in attendance. Also present were the Chief Clerk Terry L. Styer and her student Counterpart Brian Kroll from Governor Mifflin High School, County Solicitor Alan Miller, Esq., and County Administrator William E. Dennis.

Commissioner Scott opened the meeting with a moment of silence and Pledge of Allegiance to the Flag.

The Commissioners welcomed all of the Youth Day students to the Commissioners meeting and asked that each mentor introduce them.
